

Dear ESU Nursing Student:

Newman Regional Health is making available three \$7000.00 forgiveness loans for Eligible students. Eligible students must be classified as a junior or senior, have an overall grade point average of 3.0 (on a 4.0) scale, and must be passing all of their classes. These forgiveness loans will be paid at a rate of \$3500.00 upon the start of the fall and \$3500.00 upon the start of the spring semester. The monies will be given directly to the student to be used however they see necessary to remain in school.

The acceptance of a forgiveness loan will mandate that a student sign a work agreement and promissory note with Newman Regional Health. The terms of the agreement set forth that the forgiveness loan will be forgiven with one year of full-time service to the hospital for each \$7000.00 accepted.
